Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dog in the judging rings. Dogs may be left in the building overnight. Exhibitors must be out of the building by 11:00 PM Friday & Saturday Night. **There will be a designated sheltie grooming area next to the ring. We ask that exhibitors be courteous in the use of chalk, as vendors will be adjacent to the grooming area.** The show site will be available at 12 Noon on Friday and at 6:00 AM Saturday and Sunday. All dogs and equipment must be removed from the building immediately following Best in Show judging on Sunday. The show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility or liability for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assume no responsibility for injury to children or spectators. All crates must be stacked. X-pens will not be allowed in the grooming area. Handlers are responsible for keeping their areas clean. Please clean up after yourself and your dog(s). Children must be kept under control at all times.

Please Note: Only food and water for the dogs will be allowed. All COOLERS will be inspected by State Fair personnel upon entering the show site, and items not for the dogs will be confiscated.

DIRECTIONS TO THE EXPOSITION CENTER

FROM I-43 NORTH: Take I-43 South to I-94 West. Go approximately 6 miles and exit at 84th Street. Turn Left (South) to Greenfield Avenue. Turn Left to 79th Street. Enter at Gate #1.

FROM 41/45 NORTH Go South. Continue South on I-894. Exit Greenfield Avenue. Turn Left to 79th Street and Turn left to Enter at Gate #1.

FROM CHICAGO/SOUTH: Take I-94 North to I-894 Bypass. Exit Greenfield Avenue. Go Right (East) to 79th Street. Enter at Gate #1.

FROM THE WEST: Go East on I-94 to 84th Street Exit. Turn Right (South) on 84th Street to Greenfield Avenue. Turn Left to 79th Street. Turn Left to Enter at Gate # 1.

FROM THE EAST: Go West on I-94, exit at 84th Street. Turn Left, (South) on 84th Street. Continue to Greenfield Avenue. Turn Left on Greenfield to 79th Street and turn left to enter at Gate #1.

For Exhibitor parking, Please enter at Gate #1 ONLY. For Public Parking, Please enter at Gate #1 or Gate #4.
